Non-Personally identifiable information collected and stored automatically:
 If the User visit our Website just to browse, read pages or download information, but do not register or provide information voluntarily, HPWWI gathers and store certain information about your visit automatically. This information cannot and does not identify the User personally.

The kind of information that is gathered automatically include the type of browser the User are using, the type of Operating System the User are using and the domain name of the Users Internet Service Provider, the date and time of the User visit and the pages the User has visited. We sometimes use this non-personally identifiable information to improve our website(s) design, content and primarily to give the User a better browsing experience.

2. Personal identifiable Information Collected: Personal information is collected from the User only when it is provided voluntarily. - 3. **Cookies:** A "cookie" is a small piece of information stored by a web server on a web browser so it can be later read back from that browser.  - Most cookies are "session cookies," meaning that they are automatically deleted from User hard drive at the end of a session. HPWWI will share / sell some or all of your personal information with another business entity should we (or our assets) plan to merge with, or be acquired by that business entity, or re-organization, amalgamation, restructuring of business. Such other business entity (or the new combined entity) will be required to follow this Privacy Policy with respect to the personal information.
- 5. Security: HPWWI strives to ensure the security, integrity and privacy of the Users Personal Information and to protect it against unauthorized access or unauthorized alteration, disclosure or destruction. However HPWWI shall not be held responsible for any loss, damage or misuse of Users Personal Information, if such loss, damage or misuse is attributable to a Force Majeure Event. A Force Majeure Event shall mean any event that is beyond the reasonable control of HPWWI and shall include, without limitation, sabotage, fire, flood, explosion, acts of God, civil commotion, strikes or industrial action of any kind, riots, insurrection, war, acts of government, computer hacking, unauthorized access to computer data and storage device, computer crashes, breach of security and encryption, etc.

- 6. Changes in Privacy Policy: The policy may change from time to time so please check periodically. The revised Policy shall be made available on the Website. Users continued use of the Website, following changes to the Policy, will constitute your acceptance of those changes.
- 7. **Governing Law**: The Terms of Use and all transactions entered into on or through the Website and the relationship between the User and HPWWI shall be governed in accordance with the laws of India. The User and HPWWI shall be subject to the exclusive jurisdiction of the courts at New Delhi, India and the User hereby accedes to and accept the jurisdiction of such courts.
